



MATERIAL HANDLING RATES

- ALL SHIPMENTS ARE REQUIRED TO HAVE DOCUMENTED CERTIFIED WEIGHT TICKETS.
IF MATERIAL DOES NOT INCLUDE A WEIGHT TICKET, SHOW MANAGEMENT AN INFORMA BUSINESS WILL WEIGH MATERIAL.
NO COLLECT SHIPMENTS WILL BE ACCEPTED.
RATES ARE BASED ON PER SHIPMENT ON THE INBOUND WEIGHT AND THE DATE/TIME FREIGHT IS RECEIVED.
STANDARD RATE WILL APPLY IF FREIGHT AND PAYMENT IS NOT RECEIVED BY THE ADVANCE RATE DEADLINE.
